# **PRIVACY POLICY**

This web site is owned and operated by Broadwater Vista Motel Pty Ltd. ACN 655 462 089 trading as Pacific Coast Motel and will be referred to as "We", "our" and "us" in this Privacy Policy. By using this site, you agree to the terms of this Privacy Policy as appears on this web site ("the web site") or which are published by us from time to time. This Privacy Policy relates to the collection and use of personal information you may supply to us through your conduct on the web site or as may otherwise be provided to us. Any personal information is managed in accordance with the *Privacy Act 1988* (Cth).

We reserve the right, at our discretion, to modify or remove portions of this Privacy Policy at any time. This Privacy Policy is in addition to any other terms and conditions applicable from time to time.

We recognise the importance of protecting the privacy of information collected about visitors to our web site and our guests, in particular information that is capable of identifying an individual ("personal information"). This Privacy Policy governs the manner in which your personal information, obtained through the web site or as part of your engagement with us, will be dealt with. This Privacy Policy should be reviewed periodically so that you are updated on any changes. We welcome your comments and feedback.

## **Personal Information**

Personal information is collected only when knowingly and voluntarily submitted. ## **Use of Information**

2. Personal information is used only for the purpose for which it is submitted or for such other secondary purposes that are related to the primary purpose, unless we disclose other uses in this Privacy Policy or at the time of collection. Copies of correspondence, that may contain personal information, may be stored as archives for record-keeping and back-up purposes only.

## Collecting information on registered users

- 3. As part of registering or enquiring with us, we may collect personal information about you in order for you to take full advantage of our services. To do this it may be necessary for you to provide additional information to us as detailed below.
- 4. Registration

Registration or enquiries may include submitting your name, email address, address, telephone numbers, and other information. You may access this information at any time by logging in and going to your account (where applicable) or otherwise by contact us.

5. If the information provided to us is inaccurate or incomplete it may affect our ability to process your booking or assist you with your enquiries.

### **Credit Card Details**

6. Credit Card details are only stored for the processing of payment and will be deleted once payment is processed.

## Disclosure

- 7. Apart from where you have consented or disclosure is necessary to achieve the purpose for which it was submitted, personal information may be disclosed in special situations where we have reason to believe that doing so is necessary to identify, contact or bring legal action against anyone damaging, injuring, or interfering (intentionally or unintentionally) with our rights or property, users, or anyone else who could be harmed by such activities. Also, we may disclose personal information when we believe in good faith that the law requires disclosure.
- 8. We may engage third parties to provide you with goods or services on our behalf. In that circumstance, we may disclose your personal information to those third parties in order to meet your request for goods or services.

### Security

- 9. We strive to ensure the security, integrity and privacy of personal information submitted to us through our site or otherwise, and we review and update our security measures in light of current technologies. Unfortunately, no data transmission over the Internet can be guaranteed to be totally secure.
- 10. However, we will endeavour to take all reasonable steps to protect the personal information you may transmit to us or from our online products and services. Once we do receive your transmission, we will also make our best efforts to ensure its security on our systems.
- 11. In addition, our employees and the contractors who provide services related to our information systems are obliged to respect the confidentiality of any personal information held by us. However, we will not be held responsible for events arising from unauthorised access to your personal information.
- 12. IP Addresses

Our web servers gather your IP address to assist with the diagnosis of problems or support issues with our services. Again, information is gathered in aggregate only and cannot be traced to an individual user.

13. Cookies and Applets

We use cookies to provide you with a better experience. These cookies allow us to increase your security by storing your session ID and are a way of monitoring single user access.

This aggregate, non-personal information is collated and provided to us to assist in analysing the usage of the site.

### Access to Information

- 14. We will endeavour to take all reasonable steps to keep secure any information which we hold about you, and to keep this information accurate and up to date. If, at any time, you discover that information held about you is incorrect, you may correct that information by, in the first instance, logging in and correcting such information or, if this is not available you may contact us to have the information corrected.
- 15. In addition, our employees and the contractors who provide services related to our information systems are obliged to respect the confidentiality of any personal information held by us.
